Applications are invited from students belonging to minority communities namely Muslims, Sikhs, Buddhists, Christians & Zoroastrians notified by the Central Government, pursuing education, from Class 1st to Xth, in recognized school/institute to be awarded by the Ministry of Minority Affairs, Government of India.

Conditions for scholarship

- (a) To student of Indian Citizen residing in Haryana State only.
- (b) Maintenance allowance will be credited into the student's bank account.
- (c) The continuance of award will be subject to securing 50% marks in the previous examination. In the case of students of class Ist, the income criteria only would be applicable.
- (d) A scholarship holder under this scheme will not avail of any other scholarship/stipend for pursuing the same course.
- (e) The annual income from all sources of the student's parents or guardian should not exceed Rs.1 lakh. Inter-se selection weightage will be given to poverty.
- (f) 30% of scholarships is reserved for girl students.
- (g) Scholarships will not be given to more than two students from a family.
- (h) The student/institution should mention the details of Contact No., Bank Account Number, Bank Code Number and E-mail ID, so that maintenance allowance/course fee can be deposited in his/her account. If account No./Bank Code No. is not mentioned, the scholarship will not be sanctioned.

- (i) To Indian Citizen Students, residing in Haryana State only.
- (j) Maintenance allowance will be credited to the student's bank account.
- (k) The continuance of award will be subject to securing 50% marks in the previous examination. In the case of students of class Ist the income criteria only would be applicable.
- (l) A scholarship holder under this scheme will not avail of any other scholarship/stipend for pursuing the same course.
- (m) The annual income, from all sources, of the student's parents or guardian should not exceed Rs.1 lakh. Inter-se selection weightage will be given to poverty.
- (n) 30% of scholarships is reserved for girl students. In case girl students are not available then the scholarships earmarked for them will be awarded to eligible boy students.
- (o) Scholarships will not be given to more than two students from a family.
- (p) The student/institution should mention the details of Contact No., Bank Account Number, Bank Code Number and E-mail ID, so that maintenance allowance/course fee can be deposited in his/her account. If account No./Bank Code No. is not mentioned, the scholarship will not be sanctioned.
